Our world changed in March, and your Community Foundation has been working since then to help Hendricks County meet the challenges of COVID-19. Thanks to additional seed funding from the Duke Energy Foundation and Hendricks Power Cooperative, HCCF launched the **All In, Hendricks County Rapid Response Fund** to support nonprofits that serve those most directly impacted by COVID-19. All In, Hendricks County came from our partnership with Visit Hendricks County's focus on the good things happening in Hendricks County.

Phase 1: March 16 – July 31, 2020

Phase 1 provided unrestricted grants to organizations particularly those providing the front-line response to COVID-19 impacts. Typically health and human service organizations, nonprofits could apply for up to \$1,500 each month to cover additional expenses while meeting and adjusting to new needs and a rise in clients.

Total Grants: \$41,749

Phase 2: September 1 – December 31, 2020

Total Grants: \$154,000

After the initial wave of Rapid Response grants, HCCF recognized that many of our local nonprofits were struggling to meet their year-end fundraising goals due to COVID restrictions. To help meet these funding gaps, HCCF provided a matching grant opportunity to seventeen organizations to continue to support the needs of local nonprofits as a result of the pandemic.

These grants are unrestricted but require a \$1 to \$1 match to encourage charitable giving from our community to support their fundraising efforts.

Other COVID-19 Grantmaking: March – December 2020

Total Grants: \$339,758.10

Twenty-two funds of the Community Foundation made grants for COVID-related needs in the Hendricks County, including the All In, Hendricks County Rapid Response Fund, to meet extraordinary needs beyond the two phases including providing laptops and hotspots to residents forced to work and learn from home (Hendricks College Network); childcare support (Childcare Answers); and access to affordable mental health services (Hendricks County Trauma Resource Center).

It's been a difficult year for all of us, and your Community Foundation has stepped forward in new and bold ways to help our community. **We've made over \$535,000 in total pandemic response aid grants, part of over \$1.2 million in grants this year.** Thank you donors for helping us make a difference in 2020!
